We do not store or have access to your payment card details.

## 3. How We Collect Your Data

We collect personal data when you:

- Contact us via email or the website
- Sign up to receive updates or newsletters (where you have opted in)

## 4. How We Use Your Data

Your personal data is used to:

- Manage bookings and attendance
- Send confirmations and essential event information
- Communicate changes or updates related to your booking
- Share information about future offerings where consent has been given

---

## 5. Lawful Basis for Processing

Under UK GDPR, we process personal data on the following lawful bases:

- **Consent** – where you have opted in to communications
- **Contract** – where processing is necessary to deliver a booked service
- **Legal obligation** – where required by law

---

## 6. Sharing Your Data

Your personal data is never sold.

We may share data only when necessary with:

- Payment providers (such as Stripe or PayPal) to process transactions
- Venue partners where required for event delivery (e.g. attendee numbers only)
- Legal or regulatory authorities if required by law

---

## 7. Data Storage and Security

We take appropriate technical and organisational measures to safeguard your personal data and protect it from unauthorised access, loss, or misuse.

Your data is kept only for as long as necessary for business, legal, or accounting purposes.
